180 PREMIUM ENAMEL UNDERCOAT

An interior primer designed to penetrate and seal new wood surfaces. Dries to a hard sandable finish and produces excellent enamel hold-out characteristics.

1. RECOMMENDED USES: Use on new wood or plaster. May also be used for repainting old painted porous surfaces.

2. LIMITATIONS: Do not paint over chalk, dust, dirt, grease, mildew, rusty or glossy surfaces. For interior use only. Apply only when the atmospheric temperature and surface temperature will remain above 50⁰ F, and not in foggy or rainy weather.

50 Wallkyd Flat Oil, 300 Alkyd Semi-gloss, 400 Acrylic Semi-gloss, 600 Velvet Flat, 860 Imflo Alkyd Gloss, A4400 Acrylic Low-luster, 3500 Interior Flat, 4500 Interior Flat, 5500 Professional Flat, 1300 Acrylic Epoxy, 8600 Acrylic Waterborne Enamel Gloss.

6. SURFACE PREPARATION: Surface must be dry and free of chalk, dirt, grease, oil and mildew.

7. MIXING: One component. Stir thoroughly in a lifting motion before using.

8. THINNING: Mineral spirits if necessary

8. SHELF LIFE: 12 Months

10. CLEAN-UP: Mineral spirits.
