2100 Country Classic Solid Wood Stain is a heavy-bodied, penetrating linseed –oil stain. It provides exceptional water repellency, beauty, and durability to exterior wood.

Formulated with special fungicidal and wood preservatives, 2100 Country Classic Solid Wood Stain gives an opaque uniform finish that resists cracking, peeling, and blistering.

- 1. RECOMMENDED USES:** For use on new or previously stained wood, trim, siding, shingles, doors, and shutters. For best results, use 2 coats.
- 2. LIMITATIONS:** Do not paint over chalk, dust, dirt, grease, mildew, rusty or glossy surfaces. For exterior use. Apply only when the atmospheric temperature and surface temperature will remain above 50⁰ F, and not in foggy or rainy weather. Surface must be absolutely dry before applying. Solid stain is not recommended for floors or decks.

- 6. SURFACE PREPARATION:** Surface must be dry and free of chalk, dirt, grease, oil and mildew.

7. MIXING: One component. Stir thoroughly in a lifting motion before using.

8. THINNING: Mineral spirits if necessary

9. SHELF LIFE: 12 Months

10. CLEAN-UP: Mineral spirits.
