2200 Country Classic Semi-Transparent Wood Stain is a penetrating linseed –oil stain. It provides exceptional water repellency, beauty, and durability to exterior wood.

Formulated with special fungicidal and wood preservatives, 2200 Country Classic Semi-Transparent Wood Stain gives a uniform finish that resists cracking, peeling, and blistering.

- 1. RECOMMENDED USES:** For use on new or previously stained wood, trim, siding, shingles, doors, and shutters. For best results, use 2 coats.
- 2. LIMITATIONS:** Do not paint over chalk, dust, dirt, grease, mildew, rusty or glossy surfaces. For exterior use. Apply only when the atmospheric temperature and surface temperature will remain above 50⁰ F, and not in foggy or rainy weather. Surface must be absolutely dry before applying. One coat of semi-transparent stain is recommended for wood floors or decks.

- 6. SURFACE PREPARATION:** Surface must be dry and free of chalk, dirt, grease, oil and mildew.

7. MIXING: One component. Stir thoroughly in a lifting motion before using.

8. THINNING: Mineral spirits if necessary

9. SHELF LIFE: 12 Months

10. CLEAN-UP: Mineral spirits.
