7300 Instant Enamel is a high solids, fast drying modified alkyd enamel. It is designed for interior or exterior applications or OEM applications.

**1. RECOMMENDED USES:** To be used for safety pipe marking, machinery & equipment, railings, fire escapes, racks, steel support structures, conveyors, and fixtures.

**2. LIMITATIONS:** Do not paint over chalk, dust, dirt, grease, mildew, rusty, glossy or unsealed surfaces. Apply only when the atmospheric temperature and surface temperature will remain above 50<sup>0</sup> F.

**6. SURFACE PREPARATION:** Surface must be dry and free of chalk, dirt, grease, oil and mildew. Hand tool cleaning (SSPC-SP 2) or power tool cleaning (SSPC-SP 3) is preferred.

**7. MIXING:** One component. Stir thoroughly in a lifting motion before using.

**8. THINNING:** Mineral spirits or VM & P Naptha if necessary.

**9. SHELF LIFE:** 12 Months

**10. CLEAN-UP:** Mineral spirits.
