9079 Red Oxide Primer is designed to be lead & chromate free. A high solids primer formulated to meet the composition and performance specifications of SSPC-25. Special resins enhance the thru wetting ability of mild surface rust on steel surfaces.

**1. RECOMMENDED USES:** Use as a shop or field primer for structural or miscellaneous steel.

**2. LIMITATIONS:** Do not paint over chalk, dust, dirt, grease, mildew, rusty or glossy surfaces. For interior/exterior use. Apply only when the atmospheric temperature and surface temperature will remain above 50°F, and not in foggy or rainy weather. Not to be recoated with aromatic or other strong solvent paints..

**3. RECOMMENDED FINISHES:** 860 Imflo Alkyd Gloss, 8600 Acrylic Waterborne Enamel Gloss, 7000 Instant Enamel.

**4. COLOR:** Red oxide.

**6. SURFACE PREPARATION:** Surface must be dry and free of chalk, dirt, grease, oil and mildew.

**7. MIXING:** One component. Stir thoroughly in a lifting motion before using.

**8. THINNING:** Mineral spirits if necessary

**9. SHELF LIFE:** 12 Months

**10. CLEAN-UP:** Mineral spirits.
