CLEAN 5550 HEAVY DUTY VINYL BLOCK FILLER ZERO VOC

A heavy bodied , high solids, pigmented interior masonry filler sealer especially designed for porous block surfaces.

1. RECOMMENDED USES: Use as a filler-sealer on rough, porous concrete block. May be top coated with latex and solvent-thinned opaque paints.

2. LIMITATIONS: Do not paint over chalk, dust, dirt, grease, mildew, rusty or glossy surfaces. For interior use only. Apply only when the atmospheric temperature and surface temperature will remain above 50°F, and not in foggy or rainy weather.

50 Wallkyd Flat Oil, 300 Alkyd Semi-Gloss, 400 Acrylic Semi-Gloss, 600 Velvet Flat, 860 Imflo Alkyd Gloss, A4400 Acrylic Low-Luster, 3500 Interior Flat, 4500 Interior Flat, 5500 Professional Flat, 1300 Acrylic Epoxy, 1200 Polyflex Epoxy, 8600 Acrylic Waterborne Enamel Gloss.

8. THINNING: Water if necessary.

10. CLEAN-UP: Warm soapy water.
