

3550 HEAVY DUTY VINYL BLOCK FILLER

A heavy bodied, high solids, pigmented interior masonry filler sealer especially designed for porous block surfaces.

1. RECOMMENDED USES: Use as a filler-sealer on rough, porous concrete block. May be top coated with latex and solvent-thinned opaque paints.

2. LIMITATIONS: Do not paint over chalk, dust, dirt, grease, mildew, rusty or glossy surfaces. For interior use only. Apply only when the atmospheric temperature and surface temperature will remain above 50° F, and not in foggy or rainy weather.

6. SURFACE PREPARATION: Surface must be dry and free of chalk, dirt, grease, oil and mildew.

7. MIXING: One component. Stir thoroughly in a lifting motion before using.
