An extremely durable, high performance, water bourne modified acrylic, which provides superior adhesion to clean alkyd gloss and semi-gloss surfaces where maximum durability is desired. This all purpose, non-yellowing finish features hardness and durability, superior flow and leveling, fast dry, and easy application, good gloss and color retention, low odor, high hiding and excellent resistance to washing. Excellent for use over primed or previously painted metal, galvanized tin, plaster, wallboard, wood, brick, concrete, and concrete block.

1. RECOMMENDED USES: Exterior and Interior use. To be used as a finish paint for wood, trim, doors, shutters, fascia, primed steel, aluminum, galvanized iron, vinyl siding, gypsum board and masonry surfaces.

2. LIMITATIONS: Do not paint over chalk, dust, dirt, grease, mildew, or rusty surfaces. Apply only when the atmospheric temperature and surface temperature will remain above 50° F, and not in foggy or rainy weather. Avoid using in direct sunlight above 95° F.

- D. Galvanized: no primer necessary.
- E. Concrete Block: 650 Block Filler or 5550 Zero VOC Block Filler
